**CCHSRA TO HOST FREE EIR/EIS WORKSHOP AT FIRST  
BAPTIST CHURCH OF HANFORD ON AUGUST 25th**

**INVITE EXTENDED TO ALL COUNTIES AND INDIVIDUALS  
IN FRESNO-BAKERSFIELD SECTION'S PROPOSED ROUTES**

**Hanford, CA, August 17, 2012** -- **Citizens for California High Speed Rail Accountability (CCHSRA)** will host a free educational and informational workshop concerning the proposed Fresno-Bakersfield section of the California High-Speed Rail at **First Baptist Church of Hanford** from 9 a.m. to 12:30 p.m. on Saturday, August 25th. The church is located in Hanford, California.

This is the second Environmental Impact Report (EIR)/Environmental Impact Statement (EIS) workshop the Kings County-based nonpartisan advocacy group has hosted. Last September's event was held at **Kit Carson School** in Hanford which is in the proposed Eastern alignment. **First Baptist Church of Hanford** is in the proposed Western alignment. **CCHSRA** members include those who reside in the city and rural areas in both proposed routes.

Concerned individuals in Fresno, Kings, Kern and Tulare Counties are all welcome and encouraged to attend. The workshop will detail how the EIR/EIS process works along with providing the tools to provide effective comments to the California High-Speed Rail Authority (CHSRA) both in-person and via mail.

Those in the Fresno/Bakersfield section's proposed routes will have a chance to publicly testify before the California High-Speed Rail Authority (CHSRA) along with the Federal Railroad Administration (FRA) at public hearings on Monday, August 27th in Bakersfield; Tuesday, August 28<sup>th</sup> in Hanford and Wednesday, August 29<sup>th</sup> in Fresno. Meanwhile, the postmarked deadline for sending in written comments to the CHSRA is still currently Thursday, September 20<sup>th</sup>, 2012.

**CCHSRA** Co-Chairman **Aaron Fukuda** encourages everyone to take advantage of the EIR/EIS workshop to provide his or her feedback and impacts. “This workshop provides a unique opportunity for everyone in the Fresno-Bakersfield alignment to participate, learn and be prepared,” he said. “It will be too late after September 20<sup>th</sup>.”

**Citizens for California High-Speed Rail Accountability (CCHSRA)** received the **Kings County Farm Bureau’s President’s Award for 2012** this past June for their work in advocating for local agriculture. The group has and continues to work with both agricultural and non-agricultural interests throughout the Central Valley and California.
